

## **#THRIVEBUCKETLIST CHALLENGE CONTEST RULES:**

## NO PURCHASE NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING.

**PROMOTION DESCRIPTION:** The Thrive Regional Partnership "Bucket List" Contest (the "**Contest**") begins on or about January 15, 2020 at 10:00 a.m. Eastern Time ("**ET**") and ends when a winner has been determined or on March 31, 2020 at 10:00 a.m. ET, whichever comes first (the "**Submission Period**"). During the Submission Period, entrants will have the opportunity to upload personal photographs (collectively, a "**Submission**") that mark a visit to three (3) locations on Thrive's Bucket List map - one (1) each in Alabama, Georgia, and Tennessee. One (1) winner will be selected, as more fully set forth below. By participating in the Contest, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Thrive Regional Partnership (**"Thrive"**), P.O. Box 1008, Chattanooga, TN 37401, which shall be final and binding in all respects.

**ELIGIBILITY:** The Contest is open only to residents of the United States who are 18 years of age or older at the time of entry. Officers, trustees and employees of Thrive, and each of their immediate family members and/or people living in the same household are NOT eligible to enter the Contest or win a prize. This Contest is void where prohibited.

**HOW TO ENTER:** To participate in the Contest, you must have an Instagram account. During the Submission Period, upload your personal photos from three (3) of the 47 locations on Thrive's Bucket List map - one (1) each in Alabama, Georgia, and Tennessee. Upload each Submission to your Instagram account with the hashtag #ThriveBucketList (the "**Hashtag**") and tag @thriveregionalpartnership (the "**Mention**") in the post during the Submission Period. You must follow @thriveregionalpartnership, and your Submission must include the Hashtag and the Mention in order to be eligible. Your Instagram

account must be set to permit public viewing of your photos in order for Thrive to receive your Submission. By using the Hashtag in connection with your Instagram post, you are acknowledging and agreeing that Thrive has the right to use your photo as described herein.
